KNOW ALL PERSONS BY THESE PRESENTS, that I, Renée James, hereby make, constitute and appoint each of Sujata Pagedar, Kristina Benson, and Adam Arms, each acting individually, as my true and lawful attorney-in-fact, with full power and authority as hereinafter described on behalf of and in my name, place and stead to:
